

#### Introduction

The Further Education and Training Certificate: Freight Forwarding and Customs Compliance, level 4, is an occupational qualification for individuals entering or already working in the freight forwarding and customs compliance environment.

The programme develops theoretical and practical application-based knowledge and skills to offer world class client service in the international logistics and supply chain management sector. It covers trade systems, policies, procedures and legislation, administering import and export transactions, insurance and communication and numeracy fundamentals.

The qualification offers career entry and learning progression for those wanting to work in freight forwarding and customs and allied transport and logistics industries. It can be used to gain entry into qualifications at an NQF level 5.
