

Introduction

The National Certificate: Wholesale and Retail Operations, level 2, is an entry level occupational programme for individuals working in the wholesale and retail sector in different sizes and types of organisations and SMMEs.

It covers core and fundamental unit standards in broad areas of wholesale and retail operations and electives that focus on chain store operations. Subjects include customer service, processing payments and recording transactions, merchandising, communication and numeracy.

The qualification offers a career path and progression to level 3 qualifications in specialists areas of Wholesale and Retail such as operations, administration and merchandising.

Target Audience

This programme is aimed at individuals entering the industry and those already working in wholesale and retail, seeking a formal qualification. It is suitable for both formal and informal business owners and those working for large chain operations.

It prepares delegates for work in sales, purchasing, telemarketing, merchandising, warehousing, help desk operations, administration and credit management.
